FAMILY STRENGTHENING EDUCATION PROGRAM

Family Strengthening Education Program impacted families in the Treasure Valley through its hybrid education program with both virtual and in-person options. Resources such as diapers, wipes, and personal hygiene products and/or referrals to partners helping with housing, employment, and medical assistance remained high-demand requests that were provided with the help of the generous community in which we serve. Parents choosing to enroll in our courses during a pandemic, when time and resources would expectantly be geared towards other needs, is a testament that parents desire to learn skills and strategies to help become a better parent and keep their children safe.

CASA PROGRAM

For the first time in four years, the 4th CASA served 100% of abused, neglected, or abandoned children appointed to the program in FY21! We are also expanding our training in FY22 to include youth advocacy. Once the training is fully implemented, we will enlarge our best interest advocacy to serve youth (ages 12-18).


