Fiscal year 2023 saw Family Advocates focused on the future of the families we serve and our organization. We created a 3-year strategic plan, looking at each aspect of the organization and where we could foster growth, create opportunities for our families, and build a strong future for the organization.

We extended our reach in the community by hosting new events; our very first annual For the Love of a Child Gala where over 200 guests attended a beautiful evening in support of our mission, the first ever Strive Life Skills Conference for our Family Strengthening Education Program, and our CASA program offered the first ever Fostering Futures Training for staff and Guardians to learn how to support older youth in our foster care system.




Total Net Assets: \$1,570,568

Total Revenue: \$1,356,916


Total Expenses: \$1,487,827

# Over 16,000 hours were donated by volunteers in support of the CASA Program.

In FY23, the 4th Judicial District CASA Program served 100% of the children appointed to the CASA Program with a volunteer Guardian ad Litem. Guardians ad Litem and pro bono attorneys donated 13,376.87 hours and drove 64,720 miles to provide best interest advocacy for foster children in our community. In FY23, CASA recruited and trained 31 new Guardians ad Litem and 10 new pro bono attorneys.

#### FAMILY STRENGTHENING EDUCATION



In FY23, we expanded our course offerings by developing an Advanced Resiliency course for those who have graduated from the family resiliency course and want to learn more. We also increased the accessibility of our program by offering our Family Resiliency course in Spanish.

In addition to our courses, The Family Strengthening Education Program also hosted our first ever STRIVE conference. This conference featured informational sessions on various topics related to life skills as well as booths in which various community partners were able to share resources with those who attended.
